
# Boy Scouts Paint Shelter House Using Paint Iowa Beautiful Grant

# Unintentional Drowning: Get the Facts Information from Center for Disease Control and Prevention

Every day, about ten people die from unintentional drowning. Of these, two are children aged 14 or younger. Drowning ranks fifth among the leading causes of unintentional injury death in the United States. About one in five people who die from drowning are children 14 and younger. For every child who dies from drowning, another five receive emergency department care for nonfatal submersion injuries. More than 50% of drowning victims treated in emergency departments require hospitalization or transfer for further care (compared with a hospitalization rate of about 6% for all unintentional injuries). These nonfatal drowning injuries can cause severe brain damage that may result in long-term disabilities such as memory problems, learning disabilities, and permanent loss of basic functioning.

The main factors that affect drowning risk are lack of swimming ability! Many adults and children report that they can't swim. Research has shown that participation in formal swimming lessons can reduce the risk of drowning among children aged 1 to 4 years. However, many people don't have basic swimming skills.

Let's not let this happen to our Laurens area residents by not having a swimming pool to provide swimming lessons!

# Farmers Learn Science of Interpreting Soil and Manure Tests August workshops on nutrient testing and manure application may help improve farmers income.

Summer is the best time to apply livestock manure for crop fertilization, but getting the right level is a science. To aid farmers in nutrient management, Iowa State University Extension and Outreach dairy specialists are offering a workshop to fine-tune manure applications with soil management practices and testing.

"We will take a step-by-step approach on how to read a soil test and determine fertilizer needs," said Ryan Breuer, dairy specialist with ISU Extension and Outreach. "Instructions will be offered for reading a manure test and determining how much of the crop nutrient needs can be met with manure applications. This knowledge will optimize on-farm resources, and likely reduce commercial fertilizer costs while increasing producer income."

The 2-hour workshop is from 10 a.m. to noon, with the first hour training on manure management 'how-to' with examples and a step-by-step guide. The second hour will be question and answer time with Extension specialists. Leading the sessions are Brian Lang and/or Joel DeJong, both field agronomists with ISU Extension and Outreach. Participants may bring along recent soil and manure tests from their farm operations for interpretation.

## New Tools Available to Calculate Projected Payments Granted by 2014 Farm Bill

Three new resources have been developed by Iowa State University Extension and Outreach to help Iowa corn and soybean producers calculate Agricultural Risk Coverage and Price Loss Coverage payments for the 2014 and 2015 crop years. Posted on Ag Decision Maker, these tools will help farmers who enroll in these programs from the 2014 Farm Bill calculate the amount of the government payment if prices and/or county revenues are

"Both the Agricultural Risk Coverage and Price Loss Coverage payments depend on the marketing year average or MYA prices for commodities such as barley, corn, grain sorghum, oats, soybeans and wheat." said Alejandro Plastina, assistant professor and extension economics specialist with Iowa State University.

For corn and soybeans, the official 2014 MYA price will be announced by USDA in early September 2015. Until then, the actual amount of these payments will be unknown," Plastina said. "However, using county yields and price projections published by USDA, these payments for the 2014 and 2015 crop years can be reasonably projected by the new calculation tools." The projected prices used in the ARC/PLC payment calculators will be updated monthly.

The Agricultural Risk Coverage (ARC-CO) program is based on county revenues and acts like a type of insurance for crop producers. When yields fall below a certain level, farmers who have selected this coverage, are paid the slight difference.

Price Loss Coverage (PLC) payments offer protection when the actual crop price drops below its 'reference price' for that commodity set in the 2014 Farm Bill. PLC payments occur if the MYA price is lower than the reference price: \$3.70 per bushel of corn, and \$8.40 per bushel of soybeans.

"If ARC/PLC payments are triggered for the 2014 crop year, they will be issued after the end of the marketing year when USDA announces the official MYA price, but not before Oct. 1, 2015," said Plastina. "The 2015 crop year ARC/PLC payments won't be verified until the fall of 2016."

# Yard and Garden: Growing Potatoes

The potato is one of the most important vegetable crops in the world and a popular plant in any home garden. However, there's a lot to know about growing and storing potatoes properly. Iowa State University Extension and Outreach horticulturists have some tips on how to grow and store potatoes.

When should I harvest
potatoes? Potatoes can be harvested
when the tubers are small and
immature, known as "new" potatoes,
or when the crop is fully mature.
"New" potatoes are dug when the
plants are still green and the tubers
are greater than one inch in diameter.
"New" potatoes should be used
immediately as they do not store
well.

Potatoes grown for storage should be harvested after the vines have died and the crop is mature. To check crop maturity, dig up one or two hills

after the plants have died. If the skins on the tubers are thin and rub off easily, the crop is not fully mature. Allow the crop to mature for several more days before harvesting the potatoes. When harvesting potatoes, it is best to avoid bruising, skinning or cutting the tubers. Damaged potatoes should be used as soon as possible.

Before placing the potatoes in storage, cure the tubers at a temperature of 50 to 60 degrees Fahrenheit and high relative humidity, about 85 to 90 percent, for two weeks. The curing period allows minor cuts and bruises to heal. Thickening of the skin also occurs during the curing process.

Once cured, store potatoes at a temperature of 40 F and relative humidity of 90 to 95 percent.

Why are my potatoes knobby? Fluctuations in soil moisture levels during tuber development may cause knobby potatoes. Watering on a regular basis, about once a week, during dry periods will help prevent this problem.

There are white, raised spots on my potatoes. Why? The white, raised spots on your potatoes are

probably swollen lenticels due to wet soil conditions. Potato tubers are enlarged underground stems. Lenticels are small openings in the tuber surface that allow for gas exchange. Saturated soils may cause the lenticels to swell as gas exchange is impeded. Affected potatoes may not store as long as normal, but are

perfectly safe to eat.

Why are some of my potato tubers green? The potato tubers were likely exposed to light, either in the garden or storage. The skin on tubers exposed to light turns green due to the formation of chlorophyll. The chlorophyll itself is not a problem. However, higher levels of glycoalkaloids also develop in the green tissue. Green tubers have a bitter taste when eaten. They may also cause an upset stomach and more serious health problems.

Tubers with small green areas can be safely eaten if the green portions are cut off and discarded. It would be best to discard potatoes that are largely green.

When growing potatoes in the garden, hill soil around the base of the potato plants to prevent the tubers from being exposed to light. After harvesting, store potatoes in a dark location.
