

A Presentation on the History of Valentines Day to Laurens Women's Club

On February 14, 2025, Evelyn Hakes presented to the Laurens Women's Club at West Iowa Bank a history of Valentines Day. In overview, the origin of Valentines Day was a pagan Roman festival of fertility celebration. In the 3rd century, a priest named Valentine performed secret marriages for young soldiers who were not allowed to marry. This was against the wishes of the pagan emperor. In the 5th century, Pope Gelasius declared February 14 as the Feast of St. Valentine, making it a Christian holiday. In the Middle Ages, Valentines Day was also associated with the bird mating season. By the 18th century, people in America were commonly exchanging Valentine cards to celebrate Valentines Day. In 1913, Hallmark began mass producing Valentines Day cards. Today, about one billion Valentine Day cards are sent world wide.




Certified Handlers Course Set for March 12

Iowa State University Extension and Outreach Pocahontas County will host a Certified Handlers Continuing Instruction Course (CIC) for Wednesday, March 12, 2025. Preregistration may be required. Walk-ins on the day of the program are not guaranteed admission. The course runs from 9-11:30 a.m. The registration fee is \$45 on or before March 5 and \$60 after March 5. Extension News

Planning and Zoning Workshops for Local Officials Now Open for Registration

Iowa State University Extension and Outreach is offering Intro to Planning and Zoning for Local Officials workshops this spring to help local leaders navigate zoning laws, understand their roles and make informed land-use decisions.

Three-hour workshops will be held across Iowa to focus on real-world applications of planning and zoning principles. Luke Seaberg, an ISU Extension and Outreach community development specialist, said the sessions are designed to be interactive and practical.

"Planning and zoning decisions affect everything from housing and business development to farmland and public spaces," said Seaberg. "These workshops provide local officials with useful tools to guide thoughtful, wellinformed decisions that serve their communities."

Workshop dates and locations. Each session includes

a light dinner and networking time, giving local officials an opportunity to connect with others facing similar challenges.

Who should attend? This workshop is designed for local decision-makers, including city council members, county supervisors, planning and zoning commissioners, zoning board of adjustment members, municipal staff and regional planners.

"For many attendees, this is their first formal introduction to planning and zoning," Seaberg explained. "For others, it's a chance to get a refresher and discuss new trends and legal updates. Either way, participants leave with practical knowledge they can use in their roles."

What will you learn? The curriculum covers comprehensive planning, variances, special uses, nonconforming uses, spot zoning, hearing procedures and ethical considerations. Using real-world case studies, participants will see how these principles are applied in local zoning decisions.

"We don't just talk about zoning rules. We provide local decision makers with the tools and knowledge they need to make well-informed decisions about land use in their communities," Seaberg said.

How to register. The registration fee is \$65 per participant, with a discounted rate of \$55 per person for groups of three or more from the same city, county or nonprofit organization.

In addition to these scheduled workshops, ISU Extension and Outreach's Community and Economic Development unit offers customized, place-based planning and zoning training for cities, counties and townships across Iowa as needed.
