# Managing Weather-related Problems in the Vegetable Garden

Warm temperatures and heavy rainfall can significantly affect the growth and yield of home vegetable crops

Not all problems in the vegetable garden are caused by insect pests or diseases. Hot temperatures and heavy or inconsistent rainfall can lead to deformed fruit and low yields. Iowa State University Extension and Outreach horticulture specialists discuss common weather-related issues in the vegetable garden and offer tips for managing them.

According to Aaron Steil, consumer horticulture extension specialist, high temperatures, particularly those above 90°F during the day or 75°F at night, can cause blossom drop in crops such as tomatoes, peppers and green beans. Flowers may fail to form or fall off before pollination, leading to reduced yields.

"Temperatures above 85°F can delay ripening in vegetables like tomatoes, peppers and eggplant, causing fruit to remain green longer. Cool-season crops like lettuce, spinach and peas often stop growing altogether," said Steil. "While soil is typically cooler than the air temperature, if it exceeds 86°F, potato tubers stop forming. Heat also causes incomplete or poor pollination in vine crops like cucumbers and squash, resulting in misshapen produce."

Flavor is also affected by hot weather. Cucumbers may taste bitter, and crops like melons and carrots may have reduced sweetness as sugars are used at a higher rate in the heat, Steil noted.

Managing heat stress in crops is challenging, but Steil recommends deep weekly watering when conditions are dry to reduce plant stress and promote deep, resilient roots. Adding a layer of mulch helps lower soil temperatures and reduces water lost to evaporation. Heavy or inconsistent rainfall can also cause problems in the vegetable garden.

"Tomatoes, particularly largefruited varieties, may crack from rapid growth, especially under high temperatures and direct sunlight," said Steil. "Cabbage heads can split after heavy rainfall as excess water creates internal pressure from quick uptake."

Inconsistent rainfall can lead to blossom end rot in tomatoes, peppers and summer squash. This begins with a brown or black spot on the fruit's blossom end (bottom) because of a calcium deficiency. "The deficiency is caused by wide fluctuations in soil moisture, which impairs calcium uptake by the roots, he said. "Secondary infections follow, causing the fruit to rot."

While rainfall cannot be controlled, consistent soil moisture can reduce these issues. During dry periods, water deeply once a week. Mulch can also help reduce evaporation from the soil surface. If fruit shows signs of blossom end rot, discard it. Damaged produce with no signs of decay is still edible, but ensure it is used or processed quickly, as it will not store well.

# Preparing for an Empty Nest: A New Chapter for Parents

As children leave home for college, military service, employment or independent living, parents enter a new phase of life — one filled with change, reflection and opportunity. With a positive mindset and thoughtful planning, this transition can be both meaningful and empowering, says Barbara Dunn Swanson, a health and human sciences educator with Iowa State University Extension and Outreach.

"Parenthood is a lifelong journey of adjustments," said Swanson. "When your child moves out, your parenting role shifts. It's natural to feel a mix of emotions — pride, sadness, excitement and even uncertainty."

As parents move from the daily demands of raising children to rediscovering time for themselves and their relationships, a wide range of outcomes is possible. Some may mourn the quiet house, while others embrace the freedom. Many experience both.

"There's no one-size-fits-all approach to this transition,"

Swanson said. "But giving it some thought ahead of time can make the adjustment smoother."

Swanson offers these suggestions for embracing the empty nest:

- Acknowledge the impact. Your family dynamic is changing, and so is your relationship with your child. Tending to your own emotions helps you support your young adult's independence.
- Rekindle your relationship.
   With fewer parenting
   responsibilities, couples can
   reconnect and rediscover
   shared interests.
- Prioritize self-care. Eat well, get outside, exercise and rest. Tending to your physical and mental health helps you feel your best.
- Pursue interests. Revisit hobbies, volunteer or plan long-postponed vacations. This is your time to explore passions that may have been on hold.
- Lean on friends. Talk with trusted friends who can listen without trying to fix things.
   Sharing your feelings helps normalize the experience.
- Celebrate the milestone.
   Your child is launching into an exciting phase of life and you've helped them get

there. Take pride in that accomplishment.

While many parents find joy in this new stage, others may struggle with loneliness or relationship strain. If sadness interferes with daily life, it's important to seek support.

"We go to the doctor when we're physically unwell," Swanson said. "We should treat emotional health the same way. With the right support, many people rediscover joy and purpose."

# Beef Quality Assurance Transportation Workshops for Cattle Transporters Set for August 21 & 27

Iowa cattle transporters are invited to certify or renew their certification at a Beef Quality Assurance Transportation (BQAT) workshop in August. Two identical workshops will be offered - Aug. 21 at the ISU Extension and Outreach Office in Le Mars and Aug. 27 at the ISU Extension and Outreach Office in Sac City. Both workshops will run from 1 to 3 p.m.

Beth Doran, ISU extension beef specialist in northwest Iowa, said the BQAT certification is separate from BQA certification.

"Commercial truckers and producers who haul cattle with their own semi or trailer are required to present a current BQAT certificate at major packing plants before the cattle may be unloaded," she said.

The objectives for the BQAT training are human safety, animal comfort and protocols to prevent cattle shrink, bruising and stress – all of which benefit the beef industry.

The workshops are provided at no charge, but registration should be made two days prior to the date of the workshop you plan to attend. Participants may register by calling the Plymouth County Extension office at 712-546-7835 or the Sac County Extension office at 712-662-7131.

# Abundant Rainfall Means it's Ttime to Protect Your Animals from Biting Insects

Recent and continuing abundant rainfalls across Iowa have resulted in saturated fields and, more importantly, pooled stagnant water, all of which are breeding grounds for biting pests that can cause irritability and carcass impacts to pigs.

That's why Iowa State University extension swine specialist Colin Johnson said it's important for producers to act now to reduce those impacts.

"Numerous management steps and biological products should be overlaid to reduce and destroy mosquito and fly populations," he said. "The most critical locations to control are the respective breeding grounds. For most mosquito species, this is standing water, and for stable flies, it's decaying material such as manure, bedding, compost, etc."

Johnson said two resources from ISU's Iowa Pork Industry Center can help producers learn what to look for, how to address potential issues, and where to go for more information.

"Our new IPIC publication, Integrated Pest Management in Swine Production Facilities, focuses on management practices that can help producers mitigate insects," he said. "And this spring, Chris Rademacher and I presented an IPIC webinar on preventing carcass damage by insects."

Rademacher, who is IPIC associate director and ISU extension swine veterinarian, said it's important for producers to be proactive to avoid negative carcass impacts and protect animal health, and these two resources provide information and considerations for use now and for planning.

"The publication helps producers think through a more comprehensive approach to insect pest management and how it needs to be thought about well in advance of marketing pigs," he said. "The video shares practical strategies for implementing integrated pest management in swine barns."

The publication, IPIC 209A, is available to download from the ISU extension store at no charge. The video is on the IPIC YouTube channel, also viewable at no charge.

# Food Safety Webinar Will Help Small Businesses Strengthen Practices and Protect Consumers

The Farm, Food and Enterprise Development team with Iowa State University Extension and Outreach will offer a lunchtime food safety webinar from noon to 12:30 p.m. on Aug. 12.

The virtual event, "Safe Food, Smart Business: Understanding the Basics and the Consequences," will center on food safety as a top priority for any food business.

"Whether you're a cottage food producer, farmers market vendor or small-scale processor, understanding the basics of food safety is essential for protecting your customers and your brand," said Alex Van Alstyne, food business extension specialist with Iowa State. # 2025 Midwest Mechanical Weed Control Field Day Comes to Iowa

Explore the latest cultivation insights for both row crops and specialty crops

The Midwest Mechanical Weed Control Field Day will be held at Iowa State University's Horticulture Research Station on Wednesday, Aug. 20.

The event, now in its eighth year, will be held in partnership with Practical Farmers of Iowa and Iowa State University.

Managing weeds can be a major challenge for both conventional and organic farmers, and cultivation can be an important tool for combating weeds. This field day offers a chance to observe weeding tools of various sizes demonstrated in the field, allowing attendees to learn from company representatives and farmers from across the region.

Dan Fillius, field specialist for horticulture and commercial vegetables with ISU Extension and Outreach and co-planner of this year's field day, shared the event's benefits for local growers.

"This event is in the top tier of educational field days in our region. I'm excited that it's in Iowa this year so our growers can easily attend," he said. "I've attended in the past and have been impressed with the assortment of cultivation demonstrations on display for both row crops and specialty crops."
